

**102.7 Coyote Country Summer Cool Down
Powered by Sun Country Heating & Cooling
OFFICIAL CONTEST RULES**

These rules apply to the 102.7 Coyote Country Summer Cool Down powered by Sun Country Heating & Cooling Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a KCYE-FM 102.7 Coyote Country (“Station”). **In addition, the General Contest Rules posted at 1027coyotecountry.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on Monday, May 23, 2022 and end on Friday, June 3, 2022, excluding Monday, May 30, 2022 due to Memorial Day.
- b. To participate in the Contest, listen to the Station each weekday beginning on Monday, May 23, 2022 and ending on Friday, June 3, 2022, excluding Monday, May 30, 2022 due to Memorial Day, at approximately 7:00AM Pacific Time (“PT”), 9:00AM PT, 11:00AM PT, 1:00PM PT, 3:00PM PT and 5:00PM PT for the announcement of a unique Contest keyword (“Keyword”). Each announcement will have a unique Keyword. Once an entrant hears the Keyword, entrant may enter via the following method:
 - i. Visit 1027coyotecountry.com and follow the links and instructions to enter the Contest and complete and submit the online entry form including the Keyword. Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
 - ii. Only one (1) entry per person per Keyword is permitted. Multiple entrants are not permitted to share the same telephone number or email address. Entrants are not permitted to use multiple telephone numbers or email addresses. The deadline to enter each Keyword is fifteen (15) minutes past the hour after the airing of the Keyword (i.e. 7:15am PT, 9:15am PT, 11:15am PT, 1:15am PT, 3:15pm PT, and 5:15pm PT). Any entries received after fifteen (15) minutes past the hour or entries with the incorrect Keyword will be disqualified.
 - iii. Then, entrants must listen to the Station the following weekday morning (note: entrants from Friday, May 27, 2022 will need to listen on Tuesday, May 31, 2022) at approximately **7:40AM PT** when the Station will conduct a random drawing from all eligible entries received the previous weekday and announce the name of the potential Qualifier on-air. Once the potential Qualifier’s name is announced on-air, the selected potential Qualifier winner will have **ten (10) minutes and twenty-seven (27) seconds** to call the Station contest line at 702-597-1027. If the selected potential Qualifier calls within the required time, the potential Qualifier

will win a Qualifying Prize and be entered for a chance to win the Grand Prize, upon confirmation of eligibility. If the selected potential Qualifier does not call within the required time, the potential Qualifier will not win a Qualifying Prize or be entered for a chance to win the Grand Prize, and an alternate Qualifier will be randomly selected from the remaining eligible online entries from the previous weekday to be announced on-air. The process will continue until an entrant is deemed the Qualifier.

- c. There will be up to a total of nine (9) Qualifying Prize winners and one (1) Grand Prize winner selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in Clark County, Nevada, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.
- b. In order to claim the Grand Prize, the winner must own the home where the prize will be installed, may be required to show proof upon request.

3. PRIZES

- a. Up to nine (9) Qualifying Prizes will be awarded. Each Qualifying Prize consists four (4) tickets to Cowabunga Vegas. The Approximate Retail Value (“ARV”) of each Qualifying Prize is \$179.96.

The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). The prize(s) is awarded as is. Tickets valid only on the date(s) printed on the tickets. Tickets are not refundable or transferable, and may not be substituted or exchanged for cash or credit at any time, nor will tickets be replaced if lost or stolen. Tickets may not be sold to a third party. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond control of the Station and/or prize provider, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded element(s) of the prize(s). The Station and/or venue, in their sole discretion, reserve the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior, does not follow Station and/or venue policy regarding COVID-19 guidelines, or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize-related event. Winner understands that there are inherent risks involved in attending the prize-related event.

- b. Up to one (1) Grand Prize will be awarded. The Grand Prize consists of one (1) Trane Unit from Sun Country Heating and Cooling and includes delivery and installation, as

described below. ARV of the Grand Prize is \$22,000.

Prize Provider agrees to include the following as part of each Prize:

- a. Removal of existing equipment
- b. New breaker
- c. Reconnect to existing duct work, making an airtight plenum transition and sealing all new duct connections with mastic
- d. Reconnect to existing flue piping
- e. Reconnect to electrical (Not responsible for the condition of existing electrical lines)
- f. Reconnect to gas piping (Not responsible for the condition of existing gas lines)
- g. Reconnect condensate drain system (Not responsible for the condition of existing condensate drain)
- h. New auxiliary drain pan with safety float switch when a complete system (all indoor and outdoor equipment) is installed in attic or basement
- i. New carbon monoxide detector
- j. Meet all code requirements including pulling all necessary permits and help to arrange county inspections when possible
- k. Complete system check, test, and start up including cleaning our work area (see Peace of Mind Guarantees below)
- l. Sun Country Heating and Cooling will perform one (1) quality inspection of the new system approximately six (6) months after installation.
- m. Manufacturer provides 10-year parts warranty to the original winner only
- n. Accessories carry a 1-year parts warranty only
- o. When applicable, the heat exchanger warranty is at least 20 years or if a condensing furnace is installed the heat exchanger warranty is extended to a lifetime warranty
- p. Sun Country Heating and Cooling will provide a 5-year labor warranty with the installation
- q. If the above system is not sufficient for a winner's home, Prize Provider may choose to install a unit of higher value, in the Prize Provider's discretion at no additional cost or expense to the Stations or the winner
- r. To replace an existing unit with a comparable high efficiency new Trane unit not to exceed \$22,000.00 (since the type of house etc will effect what is needed for the install)
- s. One system only
- t. Winner will receive COMPLETE AC unit replacement within 90 days after announced barring any unseen supply shortages.

Winner is solely responsible for any cost(s) associated with building or construction permits required by any applicable federal, state or local law or regulation, as well as any tax liabilities resulting from accepting the Grand Prize.

- c. Prizes or prize certificates must be claimed at the office of the Station located at 2920 S Durango Dr Las Vegas, Nevada 89117, Monday-Friday, during regular business hours. Prize or prize certificate must be claimed within ten (10) days of winning.

Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4. SELECTION OF WINNERS

- a. Up to nine (9) Qualifiers will be notified and selected as described above.
- b. Up to one (1) Grand Prize winner will be selected at approximately 7:40AM PT on Monday, June 6, 2022 in a Station-conducted random drawing from all Qualifiers. Potential Grand Prize winner will be notified by phone and/or email promptly following the random drawing.
- c. Odds of being deemed a Qualifier depend in part on the number of eligible online entries received for each random drawing. Odds of a Qualifier winning the Grand Prize are 1 in 9.
- d. Entrants must listen to the Station but need not be present to be deemed a Qualifier. Qualifiers need not listen to the Station or be present to win the Grand Prize.
- e. Grand Prize winner must confirm acceptance of prize within ten (10) days of winning, or risk disqualification and selection of an alternate Grand Prize winner (time permitting) in a random drawing of all remaining Qualifiers.
- f. Decisions of Station management with respect to the Contest are final.
